Happy new year to the greatest people on the planet! Joyce and I are absolutely at a loss for words to express our appreciation for the in-depth prayer concern and helps that you sent during our trying time with the Covid. Joyce went to the hospital first and then I followed three days later. Unfortunately my experience was much deeper than hers. I had double pneumonia, clots on the lungs, what is known as glassy lung, and I don't know what else I had but anyway because of your prayers in intercession God raised me up and I seem to have passed the danger zone. I was placed on IV steroids 6 times a day for about seven days and then they changed it from IV to oral and I had to stay on the oral steroids about six days. Along with that I was on a vitamin therapy program of zinc, vitamin C, B1, B6, and a couple more thrown in there for good measure. However, God used all of it to bring me out of the condition that I was in and the day before New Year's I was dismissed from the hospital. Madame Joyce was dismissed four days before me and we thought we were doing good and then on the morning of January 6, Madame Joyce lost her balance, fell in the bedroom and fractured her femur bone in two places. 911 was called for her. She was taken to the local hospital again and there she has been until today. She was transferred to rehab and we're not sure how long she's going to be in rehab. Along with the repair of the femur bone she also had a titanium rod put in place from the top of the femur to the top of the knee so she is going to be 10% flesh and bone and 90% titanium rod and screws by the time we finish. Seriously we've gone through some trials but we're claiming Philippians 1:6, and going to keep on getting up and keep on going forward. As for me, they say I have got to stay on thinners for six months because of the lung clots and after that they think I will be OK to come off of them so continue to lift us up in prayer. What a comfort to know that you're there and we ask our God to give back to you many times over what you have given for us. Happy New Year! At least we can say we're off to a start. So when you are allowed to come see us when you're able, we'll leave a light on for you if we have electricity. We are looking for a meeting soon here, or there, or in the air!
